### What is a Legacy?

A legacy is a way of providing support to a charity in a very special way. By leaving a donation in your Will you would help Voluntary Action South Leicestershire continue its invaluable work.

### How to include Voluntary Action South Leicestershire in your Will

There are a number of ways to include Voluntary Action South Leicestershire in your Will:

**Residual donation:** by leaving a percentage of the residue of your estate after all dependants have been provided for.

**Pecuniary donation:** by leaving a specific sum of money, which can be index linked to preserve its value.

**Specific donation:** by deciding to leave a particular asset to Voluntary Action South Leicestershire.

Donations to charities are exempt from tax so anything you leave to Voluntary Action South Leicestershire is free from Inheritance Tax and we would receive the full amount. You can ask your Solicitor about the best way to use your Will to reduce tax.
